Conditions of Entry

Any person, partner in a firm or member of a limited company that has been trading for a period of at least two-years – supplying goods or services to Members of the Federation shall be eligible to apply for Limited Membership (called "Corporate Membership" or Corporate Members as appropriate) of the Federation. The Organisation will be admitted as a Corporate Member provided their application meets the acceptable requirements and after providing a sponsoring Corporate Member.

They may send a delegate to the AGM of the federation to express views and concerns, but have no voting rights. They may elect a representative from the ranks of corporate members to make representation to the executive council meeting (times and dates at Council's discretion) there will be no voting rights at council meeting. Corporate members are eligible for 50% discount on advertising in the FWC trade journal Window Talk. Free advertising is available in respect of partnership agreements. Names are listed under Corporate Membership in Window Talk, and on our website – Corporate Members are invited to provide editorial for free publication on their Company's achievements, advice on training and education and any matters appertaining to the cleaning industry. This editorial is subject to the discretion of FWC executive council.
